Examples of such circumstances include:

If a course is deemed not to have sufficient student numbers, we will notify you by 31 August prior to the start of the relevant academic year.

The Hugh Baird University Centre will take steps to minimise the resultant disruption to those services and to affected students, by, for example, offering affected students the chance to move to another course or institution, move to online delivery, or by delivering a modified version of the same course, but to the full extent that is possible under the general law excludes liability for any loss and/or damage suffered by any applicant or student as a result of those circumstances.

The Hugh Baird University Centre will use all endeavours to deliver the course in accordance with the description applied to it in the Hugh Baird University Centre's prospectus for the academic year in which you begin the course. However, the Hugh Baird University Centre will be entitled to make changes to the course (including to the content and syllabus of the course where developments in the subject area make that necessary, or to the location of the course or the method of delivery of the course) where that will enable the Hugh Baird University Centre to deliver a better quality of educational experience to students enrolled on the course. In making any such changes, the Hugh Baird University Centre will aim to keep the changes to the minimum necessary to achieve the required quality of experience and will notify and consult with affected students in advance about any changes that are required. If the Hugh Baird University Centre changes your course and you are not satisfied with the changes, you will be offered the opportunity to withdraw from the programme and, if required, support to transfer to another provider.
